

59 contractors win spots on Alliant contract

The General Services Administration named 59 companies as winners of its \$50 billion Alliant information technology contract. That's 30 more winners than the agency picked in July 2007 when it awarded the contract the first time. That round of awards was protested, and a federal judge told GSA that they had not properly evaluated the bids.
